Customer Case Studies

Here are some client examples of Dimerco solutions:

- One large, China-based auto parts manufacturer was challenged to quickly establish a supply line from its China factory to
 its client's giga factory in Austin, Texas, including an inbound/outbound warehouse with an assembly line, within one hour to
 the factory. Dimerco identified an ideal space (50,000-60,000 sq. ft.) near the factory in the tight U.S. real estate market with
 a customized IT solution, an integrated sea freight solution, and warehouse management.
- For the world's largest power supply product manufacturer, Dimerco provided guidance on the customs duty and tax
 implications at a new factory in Bangalore, India. Based on Dimerco's advice, the company was able to cut 10% off an Extra
 Duty Deposit a six-figure net savings and enjoy hassle-free movement of all machinery from China to India without a
 physical examination or customs queries.
- One of the world's leading semiconductor parts manufacturers had a shortage of a critical raw material which was temp-controlled, dangerous goods. This situation put the customer at the edge of shutting down the production at its Philippine factory. The customer asked Dimerco to handle a shipment that other freight forwarders couldn't address at that time. The pandemic flight restrictions required multi-leg, multi-carrier air routes and this shipment needed a maintained temperature of -18°C during the trip from Shanghai, Hong Kong, Manila and Cebu. With Dimerco's coordination, the shipment arrived in six days preventing a production shutdown for the customer.
- Many factories shut down in Vietnam with the COVID outbreaks in 2021. When production ramped up, demand was far
 exceeding supply. The holiday season sales for a fast fashion clothing brand were threatened by 2-3 weeks delay in air
 shipments from Vietnam to the U.S. Dimerco secured new capacity out of the Bangkok Airport and coordinated the crossborder trucking from the Vietnamese factories to the airport, avoiding millions of dollars potential loss for this customer.
- During the COVID outbreaks in 2022, a freight partner's operations system shutdown created a sudden need for Dimerco to manage an additional 450 shipments in two weeks. The quick turnaround by Dimerco's U.S. team helped satisfy all the inbound shipment needs of this customer.

We expect Dimerco to have consistent growth over the next decade and continue to be a major 3PL further connecting Asia with the world.

Dimerco Supports Customer Through Its First Light Aircraft Import

Dimerco beat off the competition to fulfil an urgent request to transport six civil light aircraft from USA to China navigating lockdown port congestion, unfavorable weather conditions and a time critical schedule.

Presenting 3 flexible solutions, identifying cost savings along the way and attending to every detail of the operation, including overseeing the re-assembly of the cargo to be tested on arrival at Guangyuan Airport to coincide with the granting of the customer's flight permit application.

The journey for the fixed-wing aircraft weighing almost 12 tons took from 10th May to 27th June and relied on Dimerco's long-term relationships with a network of carriers to secure passage of the cargo by rail from Kansas to the Port of Los Angeles, across the ocean to the Port of Qingdao and by truck to Sichuan.

The entire operation was coordinated by Dimerco teams in Chicago and Qingdao and each stage communicated to the client to support them through their first experience of importing light aircraft. This was particularly important when the transit time was extended with a 7-day sailing delay at LAX congestion and bad weather in Qingdao.

Dimerco's experience with complex logistics ensured a seamless and efficient operation while a contingency plan helped to minimize delays. To keep costs down, the China team worked with local customs using manual documentation to identify the most appropriate HS Code which resulted in reduced import tax for the customer. To protect the high value cargo, Dimerco also applied for cargo insurance and set up GPS tracking.

Dimerco's end-to-end optimization of the importation project was valued by the customer a leading light aircraft and business jet manufacturer, according to a Dimerco's Central Service Center (CSC). "The client was impressed by Dimerco's teamwork and efficiency in obtaining customs clearance which was completed the day after the shipment arrived and expressed their appreciation via WeChat group right after cargo was released."

This project was a prime example of why Dimerco has been recognized for its outstanding customer partnerships by media outlet Supply Chain Brain (https://www.supplychainbrain.com/articles/29428-great-supply-chain-partners) which has added the Taiwan-based global freight forwarder to its 2022 list of 100 Great Supply Chain Partners.

Dimerco launches China-Mexico air-road service

Freight forwarder Dimerco is offering a new China to Mexico bonded air-road service via the US as it looks to meet a lack of direct freight flights on the route.

The new Air+Road service utilises airfreight from China to either Los Angeles or Dallas and then cross-border trucking to transport the cargo to international cargo airports in Mexico closest to the consignee, where the goods are treated by customs as a China to Mexico airport-to-airport shipment.

Dimerco said that manufacturing operations in North America rely on rapid replenishment of component parts from China, but standard shipping options are inadequate.

Ocean freight is too slow and direct airfreight services are limited, the company said.

The service will target high-value components and offer transport times of six-eight days.

"While this transhipment solution via the US increases transit time by two to three days compared to direct airfreight service, it is 30–40% cheaper and is a practical response to the near absence of direct air freight shipping from China to Mexico," Dimerco said.

The company added that team drivers travel non-stop and only on highways to keep cargo safe.

Dimerco reports 112% rise in net profit

Freight forwarder Dimerco Express Corp (中菲行) yesterday reported net profit of NT\$2.31 billion (US\$81.18 million) for last year, up 112 percent from a year earlier, on the back of rising freight rates.

Earnings per share rose to NT\$16.98, from NT\$7.98 a year earlier, the company said in a statement.

A surge in freight rates led Dimerco's consolidated revenue to expand 70 percent year-on-year to NT\$38.98 billion last year, with sea freight revenue advancing 137 percent to NT\$16.2 billion and air cargo revenue increasing 47.5 percent to NT\$21.2 billion, it said.

The strong results encouraged the board of directors to approve a proposal to distribute a cash dividend of NT\$10.2 per share, it said.

The proposed dividend translates into a payout ratio of 60.07 percent and suggests a yield of 9.67 percent, as its shares closed at NT\$104.5 yesterday.

The dividend plan would be subject to shareholders' approval at an annual general meeting on June 8, the company said.

Rising freight rates also helped Soonest Express Co (捷迅), which focuses on air freight forwarding, increase net profit by 36 percent last year to NT\$291 million, with earnings per share increasing to NT\$9.72, from NT\$7.15 a year earlier, the company said on Tuesday.

Separately, freight forwarder and logistics operator T3EX Global Holdings Corp (台驊國際投資控股) on Wednesday sold all of its 2 million shares in Evergreen Marine Corp (長榮海運) at NT\$151 per share, booking capital gains of NT\$206 million from the sale, it said in a regulatory filing.
